- (a) on November 13, 2014, sections 1, 2, 3(a) and (b), 4(b), 5, 8(b), 10, 11(a),
12 to 18, and 19(a); section 19(d) to the extent that it enacts section 9(1)(e.1)
to (e.3) of the Tobacco Reduction Act; section 19(f) to the extent that it
enacts section 9(1)(g) and (g.1) of the Tobacco Reduction Act; and sections
21 and 23;
- (b) on June 1, 2015, sections 9, 11(b) and 19(e).
