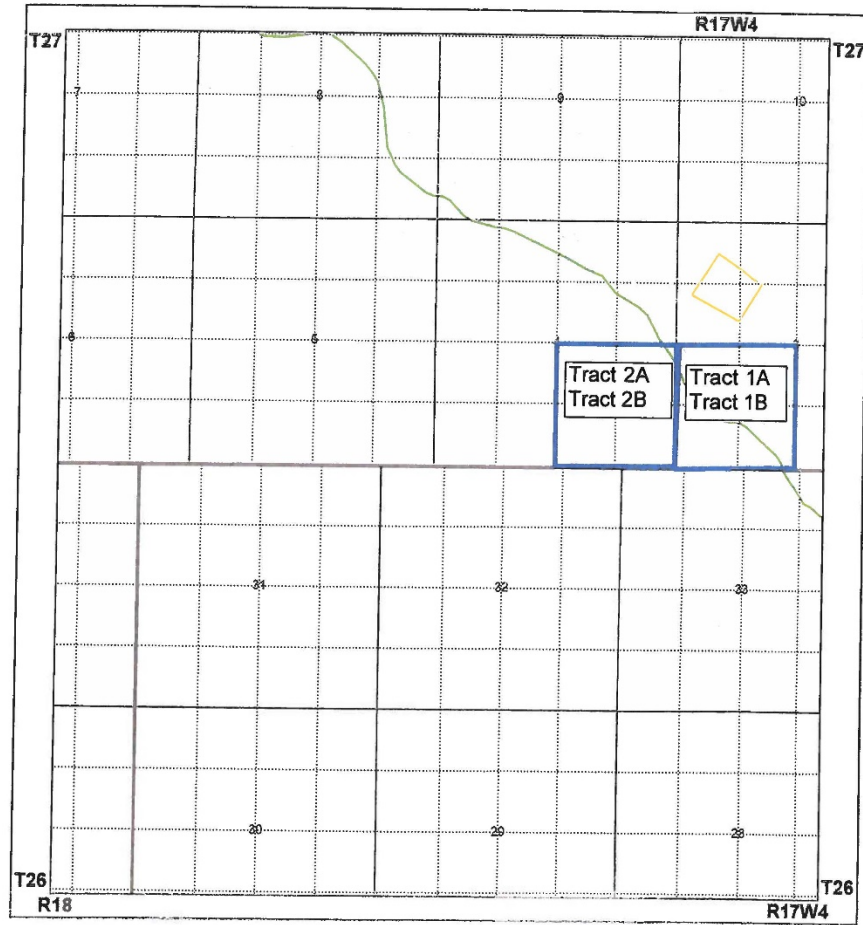

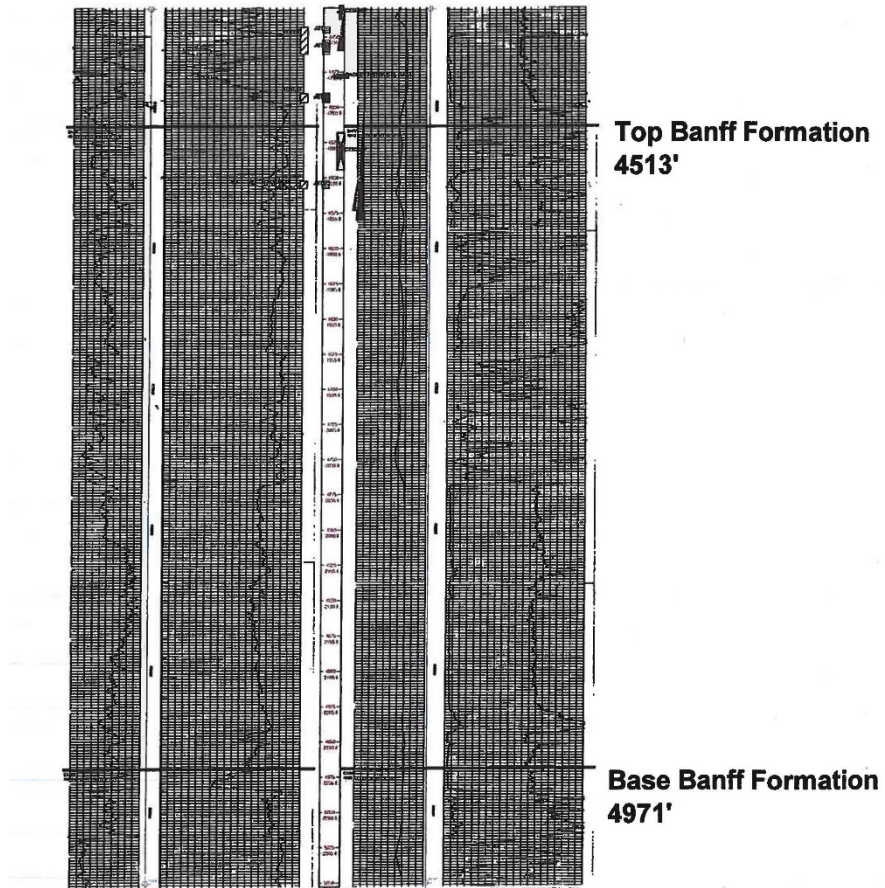

LSD 07

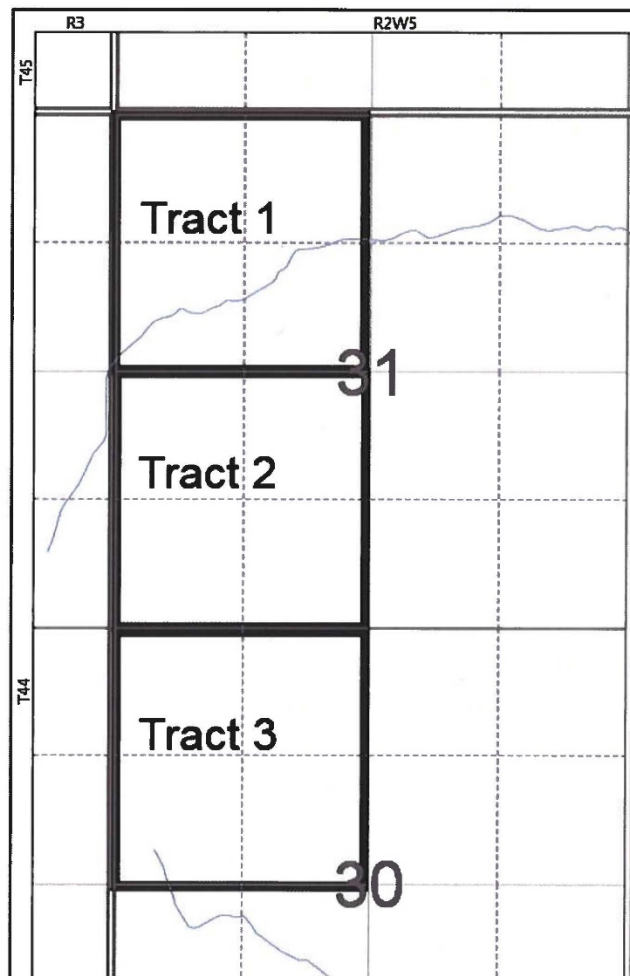

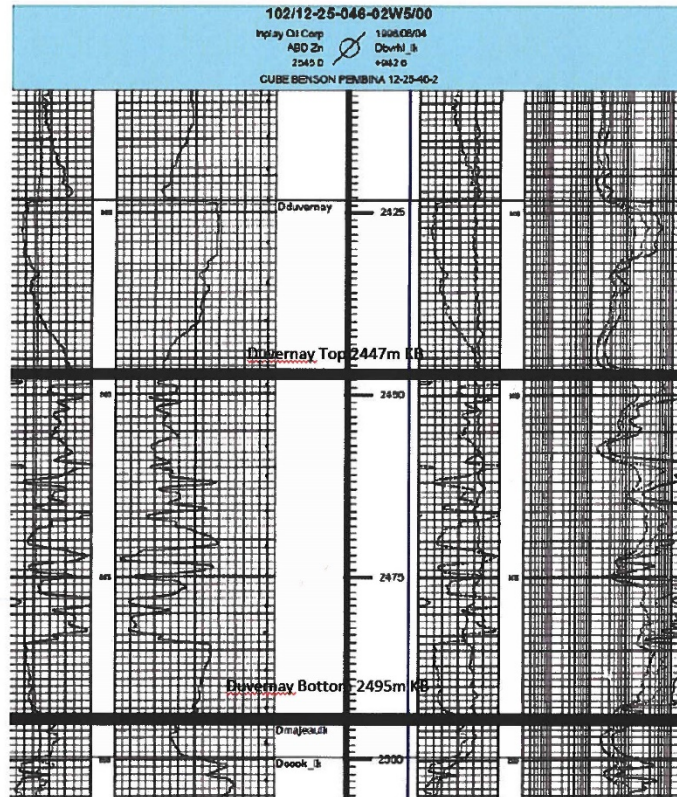

[PLAT OF UNIT AREA]

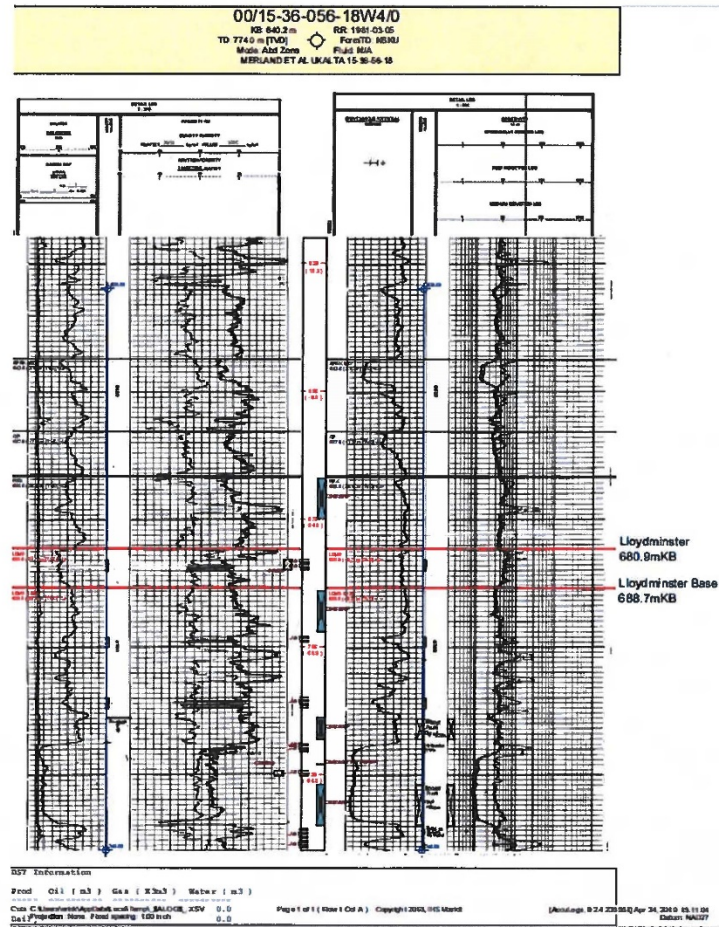
